15. 2023/139a To affirm Pennard Community Councils criteria eligibility to use the General Power of Competency in 2023-2024. As we now successfully met the eligibility criteria the affirmation was made.

- 16. 2023/140a To note renewal date for insurance and timetable for obtaining renewal quotes in respect of all insurable risks including building valuations. A three-year contract had been signed in Sept 2022 in time for the 1st October renewal. Noted.

Current subscriptions consist of membership of One Voice Wales, Society of Local Council Clerks, the Institute of Cremation and Cemetery Management, Caring for Gods Acre and the Information Commissioners Office. The Clerk gave a list of costs and explained the function of the SLCC. It was agreed to continue with the subscriptions. **Proposed by SER seconded by RC agreed by all with 1 abstention REC**

- 20. 2023/144a To agree remuneration for councillors and those with other responsibilities

The remuneration process and the amended payments were discussed, the Clerk had already sent round the 2023-24 report to all. The report stated:

Members of Community and Town Councils will be paid £156 a year (equivalent to £3 a week) towards the extra household expenses (including heating, lighting, power and broadband) of working from home. And councils must either pay their members £52 a year for the cost of office consumables required to carry out their role, or alternatively councils must enable members to claim full reimbursement for the cost of their office consumables. Both these amounts were exempt of tax.

Councillor would still be able if they wished to opt out using the form provided by the Clerk before the end of the financial year.

It was agreed to maintain the status quo for other remunerations and not increase them:

Travel and subsistence expenses financial loss compensation will be paid at the current rate.

The remuneration for Chair and 1 member with specific duties would remain at £500 The remuneration for Councillor with Financial Responsibility would remain at £500 Remuneration to cover reimbursement of care costs in line with Remuneration policy. An allowance of up to £30 for event attendance.

It was noted that these allowances were taxable
