## 1. To discuss and agree the Quarter 3 figures up to the end of December for recommendation to Full Council

## 2. To discuss and agree successful Contractor for the Ground Maintenance Contract 2022-2025 for recommendation to Full Council

The Clerk read out the quotes which covered the 3 years of the contract.

Company A – no quote

Company B - field £32459.76, hall £3100.32, burial ground £15210 with no increase

Company C – field £24112.80, hall £2448.00, burial ground £9486 with a 3% increase each year

Company D – field £20153.21, hall £2904.28, burial ground £17625.27 with a 3% increase each year

The quotes were discussed at length, the Clerk gave the Committee the clarification relating to the number of field cuts which had been asked for at the previous Full Council meeting. Company D confirmed that they had quoted for 30 cuts rather than the 34 asked for in the tender.

It was decided to recommend to Full Council that the contract be awarded to the current provider who was revealed to be Company B.
